## **MULTIANNUAL FUNDING FRAMEWORKS MODELS FOR UNIVERSITIES**

### **PROGRAM**

Multiannual programming and funding instruments by objectives are a very important tool for university policy; they allow universities and governments to collaboratively draw up strategic plans, as well as to enable their periodic renewal. These instruments make it possible to single out the missions of each university; to visualise and account for the value created and thus to devise collective goals for universities and their various structures, beyond the individual evaluation and incentives that already exist for teaching and research staff.

Undoubtedly, one of the most noteworthy new features of the new Spanish University System Organic Law (LOSU) is the commitment to set funding for public universities at a minimum of 1% of the Spanish GDP as a whole and to establish a multiannual funding framework with a structural part and another part based on objectives and specific needs.

This International Seminar aims to address these issues with the help of the Valencian Institute of Economic Research (Ivie), which is preparing an analysis of models in other EU countries and, at a national level, those of public funding of universities that have been implemented to date in some autonomous communities in order to formulate the most appropriate guidelines to develop these instruments. The seminar will bring together university leaders in economic and financial matters, as well as European representatives who will share the development of multiannual funding frameworks and programmes in their respective countries. Participants will share their views on the development and implementation of these programmes and the consequences of their implementation.

The organisation of this course and the preparation of the study are part of the agreement signed between Crue Universidades Españolas and the Spanish Ministry of Universities on the 28<sup>th</sup> March 2023 to analyse the programming instruments and multiannual funding of public universities, both nationally and internationally, and to promote their development in Spain.
